How Established Are London Based Tax Barristers Just Now?

Matters in which capable tax barristers have expertise include simplifying decisionmaking and transfer pricing enquiries. Barristers tend to be seen as litigators, but that can be a small part of their job. A barrister specialising in tax can offer expert advice on tax issues in non-contentious cases including VAT registration requirements and option to tax. The threat to democracy itself from those who promote flat taxation and who seek to take away the choices that tax enables within our economy must be highlighted to everyone who believes that the political process has to be based upon the right of people to choose. It is up to all of us to make sure that these mistakes are put right. During a tax investigation, a tax barrister may explain the investigative process and advise on how long it is likely to last. Tax planning for landed estates (including business property relief and agricultural property relief) is a matter that a UK tax barrister could advise on.

Researching, analysing and interpreting changing tax legislation in both the UK and overseas is an area that a barrister that specialises in tax needs to commit to. Businesses today have to operate against a background of ever more complex tax law and want to do the best for their business. Tax barristers tend to cost less than people expect and often less than solicitors. This is because barristers do not have the level of overheads that solicitors have so they can charge less. In general, barristers engage in advocacy (trial work) and solicitors in office work, but there is a considerable overlap in their functions. The solicitor, for example, may appear as an advocate in the lower courts, whereas barristers are often called upon to give opinions or to draft documents. The Split Between Litigation And Advisory

Her Majesty's Revenue & Customs service (HMRC) has a duty to ensure that all due taxes are paid to the Crown. It therefore has the power to conduct civil and criminal investigations and seek appropriate restitution or penalties where necessary. Domicile is a long-standing common law concept that can impact your UK income tax, capital gains tax and inheritance tax position, for any advice speak to our UK tax barrister. Organisations and individuals may obtain a licence to instruct barristers directly, either on their own affairs or on behalf of their clients, via the Bar Council's Licensed Access Scheme. Examples of areas of focus for specialist pensions experts include scheme funding issues (such as negotiating security and Pension Protection Fund levy issues); corporate restructuring exercises and company sales; scheme mergers; rule consolidation projects; scheme amendments (including closure exercises) and pensions related disputes. Experienced barristers can act as advisers to businesses facing external investigation by regulators (HMRC, the FCA and the full range of professional regulators), or pursuing internal investigations. Specialist assistance for <u>Inheritance Tax Advice</u> should be sought whenever required.

Each barrister practises alone as an individual. A barrister is not permitted to practise in partnership or as an employee, and is not permitted to practise as the employer of any legal practitioner in active practice. Tax planning in relation to the family home is something that a UK tax barrister can advise on. A specialist tax consultancy may work with individuals, businesses and other professional advisers. Pensions barristers have a deep understanding of how schemes operate in practice and specialist litigation expertise and experience. Competent tax barristers may act on behalf of members of the armed forces and the police and be accredited High Cost Case panel advocates. International Tax Matters

VAT, customs and duties are all areas that tax barristers can accept instructions in. change - including globalisation, technology, demographics and major environmental and energy challenges. Barristers provide specific, specialist legal advice. They represent individuals and organisations before courts and tribunals, in writing or in person. In Scotland, advocates perform a similar role. The UK has a regime of self-assessment which requires a taxpayer to assess its own tax affairs and declare these annually in a tax return. However, where the UK tax authority, HMRC, wishes to query or disagrees with the self-assessment, it can commence an enquiry and come to its own decision. There has been almost no real discussion during any period about what tax is for and how it contributes to the creation of the society we aspire to. Advisory services such as <u>Pensions Advice</u> are a common sight today.

Most tax barristers are happy to estimate or agree a timescale for the provision of your service or services. However, you should be aware that external factors can affect timings, such as the approach the opposing party takes to the dispute, how busy the courts or tribunals are and changes to the law. British tax barristers are occasionally asked to give counsel upon matters such as methods of computing profits (including the relevance of accountancy practice) and deductions against receipts.
